Councillor Halfhide declared a personal interest and took no part in discussions or voting.

Thorney Parish Council are opposed to this application.

In principal Thorney Parish Council is not opposed to a development of new houses on the land off Sandpit Road in Thorney and we recognise the need to build more homes and this location has already been identified for development.

However, we feel that 71 houses on this site is excessive for this area of land. The "Indicative Number of Dwellings/Remaining Site Capacity" identified on page 96 (LP39.8) of the "Peterborough Local Plan 24 July 2019" state that the number of dwellings should be 50. We find that 71 is substantially more than this recommended number and therefore oppose 71 dwellings. Thorney's biggest concerns regarding this development are its impact on infrastructure, namely school places and impact on the medical centre. We understand that both the Duke of Bedford School and Thorney Medical Practice are at full capacity. This is not an issue the developer can resolve, but it could and should be addressed using the CIL monies this development would generate. We ask that Peterborough City Council give the people of Thorney some assurances and ringfence the CIL monies raised by this application to expand capacity at the Duke of Bedford School and Thorney Medical Practice. This would not only benefit those moving into the new houses but the whole community would benefit.

In summary Thorney Parish Council strongly object this application in its current form. We would be in favour if the number of dwellings was reduced to 50 and a specified amount of CIL monies were guaranteed to be allocated for increasing capacity at Duke of Bedford School and Thorney Medical Practice which would be a great benefit to the whole community.
