Public discussion -

1. To discuss ram-raid on the Village Shop. The Chair congratulated the shop owner for opening immediately after the ram raid and expressed the gratitude of the local community has for the services the shop provides. Cllr Shearman explained Thorney Parish Council wishes to take pre-emptive action to keep the shop staff and shop safe as it is the lifeline of the village.

Cllr Simons has had site meetings with the shop owner, Conservation Officer and Peterborough City Council Contractors and assessed what action can be taken to prevent a similar raid. As Manchester type bollards are in use in other parts of the village it was agreed that 4 additional bollards, strategically placed could provide a solution.

The Chair thanked the shop owner for attending the meeting and expressed the full support of Thorney Parish Council.

2. Bedford Hall Management Committee. Invitation to Chair and Treasurer to discuss future. Management committee meeting last week. Suggested that redecoration would help to make the venue more attractive, and a possibility would be a community organised event to do this.

Bar – possibly take over by local resident. Web site to be revamped. More committee members needed although new members have recently joined.

Gas supply being renegotiated. Grant from Government via Peterborough City Council for Omicron and leisure facilities

It was suggested that the bar was the main source of income. This was accepted and for the next 6 months the existing arrangements would continue. Renegotiation would take place following that

More regular hirers are needed.

Will co-operate with museum.

3. Sport pavilion refurbishment proposals. Presentation from Thorney FC.

This project has been extremely well received by the local FA who have provided not only financial support, but they have given invaluable advice every step of the way. The same can be said for the Parish council who have also been very forthcoming with their support and advice. Following the presentation of this report it is hoped the Parish Council will release funds for the refurbishment and extension of the Pavilion. Furthermore, I have also been in discussions with the Cambridgeshire FA working our way forward looking for solutions to the optimum way of improving the quality of the playing surfaces at the park. In addition, I am in discussions with local business with a view to sponsorships for football kits and equipment for the teams.

We believe that the funding of a new pavilion will help us reach our full potential as a football club, both as a junior team and men's team. Not only will it attract more people to the park, but it will help us to host and incorporate many different sporting activities all year round. This could include, cricket, rounders, football tournaments. We believe that with the kitchen/cafe it will help attract more people to the park and participate or spectate on the relevant sport on show at the time. Children of this generation have lost so much during the recent pandemic, we believe self-confidence, is the biggest loss. There is no better time to get this project under way and give them something to attract them back outdoors.

There is a wish to involve local school for out of school activities

Thorney Parish Council said the building must be suitable for all sports users use not just football.

It was later confirmed that Peterborough City Council would still maintain the building after the works are completed. They would also take the fee for the pitch, which goes towards maintenance.

- 6. Wooden village signs Cost of repairs assessed at £250 per sign. It was unanimously agreed to go ahead with the repair
- 7. Financial considerations to stop ram raids. Bollards in footpath. Peterborough City Council contractors have quoted £750 per Manchester bollard to install. Conservation Officer met on site and agreed Manchester bollards as installed in other places in the village would be suitable. It was unanimously agreed to finance the installation of 4 Manchester type bollards from CIL to protect this valuable village asset.
- 8. Financial and long-term considerations for new pavilion in Park. Following the presentation and discussion in the public forum it was unanimously agreed to go ahead with refurbishment and extension to the Pavilion in the Park to be used for all sporting groups in the village. Peterborough City Council will contribute £55,000 to the project, Thorney Parish Council £35,000 from CIL contributions and £10,000 from Thorney Parish Council reserves. Thorney Parish Council will have Financial control and Councillors from the sub-group feedback spend as it occurs. Negotiations and supplementary decisions with Peterborough City Council, local groups, and contractors carried out by a sub-group made up of the Chair, Cllrs Simons, Potts, Williamson, Mr Scott (Thorney Football Club/Thorney Rangers) with input from Clerk if necessary.

Two more quotations were being sought for the pavilion renovation and this was proving difficult to achieve. A similar situation occurred when quotations were being sought for tree maintenance

- 9. Financial considerations for field end Gas Lane. It was unanimously agreed to have the field flailed ready for tree planting
- 10. Cllr Howard declared an interest and took no part in the following discussion or vote. It was unanimously agreed to issue a cheque for £25000 to match fund the Duke of Bedford replacement swimming pool. A further £10,000 had also been agreed at a previous meeting if

the school can match fund that additional amount. These donations will come from CIL account.
