Public discussion –

Ms. Pinguenet, Headmistress of the Duke of Bedford School, and Mr. Mark Cowdell, Chair Governors' Duke of Bedford School – replacement swimming pool

Ms. Kelly Pinguenet outlined the curriculum for swimming and life skills. The existing swimming pool was condemned, and quotes received for a replacement, covered in, pool were £70,000.

So far this year £9550 has been raised and further fund-raising functions are already planned. There is a £10000 grant requested from Wryde Croft Wind Farm fund that is expected to be approved. Initial estimates are that fund raising will achieve between £25000 and £30000. Local donations would also be explored from individuals and Companies

Various options have been considered including busing students to other facilities such as Whittlesey Swimming Pool. This has a major drawback in as much as there is only availability to take 2 classes because of Whittlesey commitments and that children would have to be taken out of school for a much longer period and this would negatively impact on the curriculum. Learning has already been severely restricted for the past 18 months by Covid 19. The curriculum target is for all children to be able to swim 25m by year 6.

Consideration is being given, and it is expected, that the pool would be part of the community facilities and open to the public at certain times

A suggestion was to enquire about a loan function possibly from the pool installation firm. This would have to be approved by the Local Authority

3. Presentation Good Neighbour Liaison – this is short term support and the notice that was advertised stated:

"Thorney Parish Council is looking into joining this Good Neighbours scheme in order to be part of a well-run scheme (recently receiving the 5 Star Focus Award for volunteer management) but in order to do so we need to know that we have a group of volunteers who will be available to carry out tasks for others in Thorney. I have shared this invitation on Facebook, on posters, and to the Women's Institute.

This is a summary of the Good Neighbours Scheme, particularly for the benefit of newer Parish Councillors:

"Here at Good Neighbours, we provide non-emergency help and support for vulnerable people in the area surrounding rural Peterborough.

We offer services such as befriending (telephone calls, reading a book, having a chat), transport in volunteers' cars to medical and social appointments, shopping assistance, pet care, and practical tasks like DIY and gardening."

The public meeting was poorly attended by residents. Outline of objectives and organisation of the scheme given. To be discussed again at a later date

- 4. The Co-ordinator, Good Neighbours-Rural Peterborough has received a direct call from the COVID Hub Team at the Local Authority regarding concerns about the COVID cases specifically in Thorney and Eye. They have asked her to arrange some outreach engagement sessions in each area. The Drop-in Vaccination bus could have a presence at Bedford Hall one day where people could come for advice and to obtain test kits which will be supplied. The Parish Council support this and will help book a suitable date, place and assistance with advertising this to the community. A Saturday would be a preferable date so that those that work can engage too.
- 5. Foodbank NPS to be asked if the lease extension could be drawn up and received for signing at our December meeting on 13th December. Thorney Parish Council is aware that this premises is on Peterborough City Council disposal list and Peterborough City Council Estates Manager writes "I have had confirmations that the extension of the licence is supported. I will instruct legal on the licence renewal.

As per the current licence, we will need to retain flexibility on the use / occupation – as you will be aware there is a general asset review related to PCC budget levelling. So, the potential disposal of the premises may be brought forward – but I do not foresee this being before the Christmas / holiday period is over and various consultations would be needed first".
