Public discussion with Superintendent Billany, Cambs Constabulary who explained his role and the large geographic area he covers.

Travellers in the Park were discussed and the way in which the Police deal with incursions was explained. Communication with local representatives gave differences in actions to be taken and the intimidation to those adjoining the Park was not acceptable nor was the action taken to stop it.

Briefings will shortly take place concerning new legislation that govern traveller's encampments and serious crime. A new database collects information from Constabularies to map similar activities – a crime in this area could be matched to a similar crime in a neighbouring area to give information based Policing.

101 reporting system and the criterion for action, (the email from a Councillor fully documented the difficulties), were also discussed. The telephone hold system was frustrating, and residents become disillusioned/hang up. The website for reporting was not user friendly. 999 calls have increased significantly so operators answering these cannot deal with 101 calls at the same time.

Not all calls can be attended to because of lack of Officers. Hence a crime number is issued for claimant's insurance purposes.

Vandalism by local youngsters, and those coming into the village, thought the area was "safe" – that is free from regular Police patrols and makes the village vulnerable to this kind of anti-social behaviour. Anti-social and criminal damage is investigated by different departments.

Superintendent Billany was fully supportive of Community Policing, and it was his intention to reorganise his department so that Thorney Parish Council would have a direct contact (in a similar way to that carried out very successfully by PCSO Webber many years ago). He is recruiting PCSO's and to fill vacancies of Police Officers. Rural areas should have more Police representation. Community Policing should be engaging with groups of youngsters to discourage anti-social behaviour.

Many calls the Police attend concern mental health issues and medical emergencies when the health service is fully committed elsewhere.
