1. To approve accounts for payment – circulated to Councillors before meeting - approved

- 2. Monthly bank reconciliation circulated approved.
- 3. Foodbank door lock change. Access to the toilets in the Church Street foodbank premises by members of the public was discussed at length and dismay expressed concerning lack of cooperation. Peterborough City Council Estates have no objection to a lock change, and it was unanimously agreed that the door locks be changed.
- 4. Thorney Pavilion financial. All invoices have now been paid for the refurbishment of the Sports Pavilion with a total cost of £39680.92
- 5. Match donation of £10,000 Swimming Pool at D of B School –Councillors Howard and Simons declared an interest and took no part in the voting. At the November 2021 meeting it was agreed that if the Duke of Bedford School raised more than our initial donation of £25000, Thorney Parish Council would match fund for upto another £10000 as the facility would also be for Community use (as agreed at November meeting by headteacher and Chairman Board Governors). The school has now reached that second match fund target and it agreed that Thorney Parish Council would match fund the £10000. Letter to be sent to School confirming their commitment to community use. Cllr Shearman to liaise with school to confirm this and offer assistance for members to participate in risk assessment for Community use.
- Donation to Thorney Children's Community Choir. The Choir entertained residents at the picnic in the park held in August. It was agreed to donate £100 to the choir to allow them to develop further
- Bollards The Causeway financial. Request made to Peterborough City council to provide a contract price for the installation of barriers similar to those on the drain side, Station Road. Awaiting estimates
- 8. Request for donation towards Theatre for Thorney. Councillor Halfhide declared an interest and took no part in the vote. Last Year, The Thorney Society brought professional Theatre

to Thorney, in the form of Peterborough based Lamphouse Theatres Christmas show Robin Hood. They wish to bring Alice in Wonderland to Thorney this year and request a donation of £500 towards the cost. It was agreed to donate this from the Covid19 recovery fund.
