- 4. Bollards The Causeway financial. Request made to Peterborough City council to provide a contract price for the installation of barriers similar to those on the drain side, Station Road. Their contract price for replacement bollards is £42000. The Highways Officer writes "have now had a price to remove all the red and black posts and replace with Oak bollards complete with reflectors as required as they will be adjacent to the carriageway and restore verges with soil and seed is approx. £42,000.

I appreciate this appears to be a lot of money but the costs for Milestone to install a new oak bollard is currently £335 each and with wood prices increasing this cost could continue to rise.

Reducing the number of replacement bollards would also reduce costs however this may allow some of the feared behaviour of parking on the area to happen.

I have spoken to PCC, and they confirm that any new type of bollards installed at this location would remain the responsibility of the parish council because PCC have insufficient budget to maintain such a large value asset. currently a reflector post like what is there now costs around £40 compared to over £300 for a wooden one so the PC will need to factor in future maintenance if this project was to go ahead

If a new oak bollard was to become damaged PCC would only clear the site and reinstate the verge." Proposed, seconded and agreed Thorney Parish Council will not pay for replacement bollards. Cllr Halfhide declared a personal interest and took no part in discussion or vote

22/01330/LBC Proposal: Conversion of modern existing garage to granny annexe Site address: 87 Station Road Thorney – no objection

21/01796/FUL Proposal: Construction of 68 dwellings and associated infrastructure Site address: Land Off Sandpit Road Sandpit Road

Councillor Halfhide declared a personal interest and took no part in discussions or voting.

Thorney Parish Council has no reason to change the views expressed previously and are opposed to this application.

In principle Thorney Parish Council is not opposed to a development of new houses on the land off Sandpit Road in Thorney. We recognise the need to build more homes and this location has already been identified for development.

However, we feel that 68 houses on this site is excessive for this area of land. The "Indicative Number of Dwellings/Remaining Site Capacity" identified on page 96 (LP39.8) of the "Peterborough Local Plan 24 July 2019" state that the number of dwellings should be 50. We find that 68 is substantially more than this recommended number and therefore oppose 68 dwellings. Thorney's biggest concerns regarding this development are its impact on infrastructure, namely school places and impact on the medical centre. We understand that both the Duke of Bedford School and Thorney Medical Practice are at full capacity.

22/01048/OUT Proposal: Outline application for the change of use of offices/carparking into 10 dwellings with access secured and all other matters reserved Site address: Peacock House Station Road

This development was not included in the Peterborough Local Plan 24 July 2019 and is in the flood plain area. There is a large bank of earth to the west of the site that an adjacent householder blames for water run off flooding his garden – this problem should be addressed.

Thorney's biggest concerns regarding this development are its impact on infrastructure, namely school places and impact on the medical centre. We understand that both the Duke of Bedford School and Thorney Medical Practice are at full capacity.

22/01372/HHFUL Proposed replacement pitched roof over existing garage and double oak framed carport extension at 53 Wisbech Road Thorney – no objections
