Whittlesey Road speeding and traffic issues – meeting with Peterborough City Council Officers - ongoing

Bedford Hall roof gullies need clearing annually to avoid water ingress as happened in recent storm – liaison with Peterborough City Council Officers concerning clearing of valleys, gullies and hoppers. Thorney museum has a problem that when water is pumped from the basement and the drains are full the water floods from the manhole cover. Dyno-rod has investigated and there may be a blocked drain towards the river.

Fenland Council now operating a policy of infill homes in rural areas between existing properties Old Knarr Fen Road in very bad state of repair.

Pavilion Roof water pooling – quote and offer to repair defects rejected. Roof is not fit for purpose and must be repaired by contractor at his cost. Legal action to be considered Some missed bin collections

Reserved Matters Approval relating to scale, layout, design, appearance and landscaping pursuant to 22/00275/FUL Proposed hybrid planning application for the proposed Grantham to Bexwell Pipeline Scheme with full planning consent sought for a proposed 95k pipeline and 4 kilometer spur, and outline consent for associated above ground infrastructure at Elton and Welby Heath – no objections

23/00319/FUL Proposal: Proposed 4 bed bungalow and associated works Site address: Land South Of 3 Ernest Lane Thorney – Councillor Howard declared an interest and took no part in the discussion - no objections

22/01710/FUL Proposed Storage Units (B8) with enlarged Hardstanding, revised Entrance gate and provision of Security fencing Site address: Dalmark Grain Knarr Farm Wisbech Road – Thorney Parish Council object to this industrial development in open countryside – Thorney Parish Council's view is the same as the original application and oppose this development. This appears to be an application for a scrap metal yard on a considerable scale. An extra two large buildings are proposed on the boundary with the A47, which will be clearly visible, and open storage of scrap metal between the buildings and Knarr Farm. No mention is made of the group of smaller buildings, also on the boundary with the A47, which lie between the proposed scrap yard and Knarr Farm.

Grade II listed Canary Cottage is described as vacant and deteriorating, which seems to imply it should not be used to prevent this application. Thorney Parish Council think that it is incorrect that the landowners think the wording given in the Heritage Statement is appropriate for a Listed Building and conditions should be applied to protect this monument

- 1. Speedwatch continuing throughout village. Generally, speeds are within limits.
- Whittlesey Road meeting with Peterborough City Council Officers who gave estimates for some modifications including 2 speed warning signs at £11,000 and Peterborough City Council would expect a 50% contribution from Thorney Parish Council
- **3.** Road crossing Station Road near Chestnut Drive At this point Councillor Winwright left the meeting
- 4. Road names new development off Sandpit Road, Abbey Park stage 2 suggestion were Plough, Shepherd's, Culpin (Claude Culpin O.B.E. (1910-1995) wrote a classic book on Farm Machinery, 1st edition in 1938 which was published in 12 editions until 1992), Lambert (Dr James Lambert, buried in Thorney in 1830, bore witness against a fellow surgeon in Westminster Hall, beginning the accountability of the surgical profession in courts of law. He is the first British doctor to have an obituary in The Lancet), Morris (Rear Admiral George Morris (1775-1857) joined the navy at the age of 14 and lost a leg in action at the age of 19. He was promoted to the rank of Rear Admiral in 1846. He retired to Gores Farm, Thorney and is buried in Thorney Abbey churchyard).
- 5. Wisbech Road north and Sandpit Road suffering from overgrown vegetation into footpath Peterborough City Council to be asked to investigate.

6. Area corner traffic lights adjoining river – private hedge needs cutting and vegetation strimmed.

Ponding should not occur in a new installation and because it has, the new roof installed as part of the contract is not fit for purpose, therefore, Thorney Parish Council insist Virtue Properties correct the defective work at their cost. This work should be carried out immediately, so no further damage occurs, and Thorney Parish Council need to know when this work is to be undertaken so that users of the Pavilion can be informed that it is out of use.
