## 2551/23-24 Building Church Street used as foodbank.

The licence Thorney Parish Council hold for this premises was circulated before the meeting. Chairman and Clerk visited the TBBT session at Church Street on Friday afternoon, and talked to Nate McDowell, the Area Manager for the East Midlands. TBBT is a registered Charity, set up initially by Mark Game, who would like to see it spread nationwide in time.

# The Bread-and-Butter Thing mission statement is:

Our mobile food clubs give access to nutritious and affordable food taken into the heart of communities starved of money, food and resources. This low-cost weekly shop provides essential produce for family eating – fresh fruit and veg, fridge favourites and cupboard staples.

The operation is basically mobile, with a large van (similar in size to those used by supermarkets for home deliveries) arriving at Church Street around 12.00 on a Friday afternoon. First of all, the hall is cleaned and all the surfaces are disinfected, before the trays/boxes of produce are off

loaded. Bags are then filled with either fruit and veg., or ambient ingredients such as eggs, crisps, tins, etc and placed on the tables. All chilled food is left in the van. At 2.00 pm the first customer is allowed inside but, because of the steps to the door, only 5 customers are allowed in initially. They are given a token as they enter, walk round the table to pick up their own bags, and return to the pavement outside. They hand their token to the volunteer in the van and are given a bag of chilled ingredients. As one customer leaves the room one customer is admitted (this is all in line with Health and Safety). After all bags are distributed, the hall is cleaned and all surfaces are re-sterilised, all cardboard/packaging is loaded on to the van to be taken for re-cycling, together with all the food trays.

The local volunteers are away by about 4.00 pm.

The total number that can be safely accommodated on any one day is 80, and it is being operated to serve the Thorney area. A single, mixed bag of ingredients (for a single person) is charged at £5.00, three bags for a family is £8.50, and a large pick for a big family is £17.00. They aim to provide a retail value of £40.00 for the basic three bags, and the standard of food offered is excellent. It is incredible to think that all this food, contributed by supermarkets and farmers, is due to go into land fill.

We were told a risk assessment for the premises had been undertaken.

#### 2555/23-24 Roads and Footpaths

Speeding in Village— Speedwatch continue to provide regular speed checks. 3 speedwatches in December, 2 mornings on Whittlesey Road and one mid-afternoon on Station Road. The situation is greatly changed at times when the Whittlesey Wash closes the B1040 and the North Bank, so one very quiet session. During one Whittlesey Road session, 31 vehicles (almost 27% of the traffic) were going over 30mph despite Speedwatch being there, and 7 vehicles (8 %) were doing over 34mph.

As the days get longer it is easier to timetable Speedwatch sessions. Volunteers are still needed. Realistically you need to be available during the day in the autumn to spring months to have adequate daylight but help in the evening would be welcome in the summer.
