Public discussion -

Thorney Tennis Court- a resident requested an update. The Peterborough City Council is in open consultation regarding the parking, tennis court and lights. Cllr Ormston advised they are trying to get funding for all. Advised they a private quote for a tennis court refurbishment would be over £30,000. Cllr Ormston will try and get holes in surface repaired.

Peterborough Local Plan- A resident raised his concerns over the on-going development of Deer Park and potential development in the Parish.

Another resident highlighted that there were 5 residents attending to speak in opposition to the proposed land for development in the local plan.

Public open space allocated in the phase 2 plan is now being allocated for housing in 'phase 3'. Concerns regarding Doctors, School places and infrastructure.

A residents created and circulated their own leaflet encouraging residents to respond to the local plan.

Cllr Ormston- advised need to be planning reason for objections, for example: loss of light, infrastructure challenges.

Planning reasons given mentioned by residents: public open space, biodiversity, drainage, road infrastructure, amenities, loss of privacy.

Malice Farm- Solar Park. No further information provided to residents or the Parish Council. A resident has tried to contact them twice and they have not responded. The Clerk offered to supply their email address.
