- 1. To approve accounts for Payments and Monthly bank reconciliation approved.
- 2. Request from windfarm fund for dog waste bin end Gas Lane this was agreed.
- 3. Tennis court surface From Cllr report minute "PCC confirmed Tennis Courts are their responsibility and have an ongoing review all parks/pavilions which will not be complete until 2026, so no further work will take place to Pavillion or courts". Patching maybe a temporary way forward. The Clerk asked if the City Councillor whether PCC would provide a quotation for patching and Cllr Ormston agreed to liaise.
- 4. Consider electronic device for Chairman to use purely for Thorney Parish Council business. Most correspondence is sent out and received by the Clerk who has a Thorney Parish Council laptop. However, the Chairman also deals with correspondence, particularly electronically, from a personal device. With advanced hacking techniques I believe the time has now come for the Chair to also have a Thorney Parish Council electronic device that Thorney Parish Council keeps updated with protection software. It was proposed by Cllr D Winch seconded by Cllr L Moore and agreed a tablet would be purchased for the Chairman with a budget up to £1500.

#### 2814/25-26 Parish Council business

1. Picnic in the Park and risk assessment. Clerk has put together a very basic risk assessment. Mr Parker (ex TFL risk assessor) agreed to assist the Clerk in drawing up the risk assessment. Peterborough City Council requires this and so will our insurers if there is an incident. The Clerk suggested a representative from the Parish Council should be present as a contact point. It was agreed to order 800 leaflets, and 7 posters, Cllr Halfhide, Winch, Moore and Long will deliver leaflets. Village Facebook page- advertise of they want a stall contact Cllr Moore. Cllr Moore and Cllr Francis will meet to discuss the set up.

- Digital Inclusion Rural Opportunity and funding update
  Ongoing discussion on how to address digital inclusion in rural areas.
- 3. Use of two factor identification for email this security system is coming in for many things now and should be part of our ongoing procedure.
- 4. IT Policy procedure approval. This is now a mandatory item and will have to be submitted at the next external audit. I think the Chairman's electronic device and 2 factor authentication proves we are serious about the process in the same way as we are about finances and the monthly bank reconciliation that is circulated. It was proposed by Cllr Mills seconded by Cllr Wren and agreed to accept the policy.

25/00793/LBC - Proposal: Proposed truncation of a section of internal walling and reinstatement of York flagstone hearth to front room at 76 Wisbech Road – no objections

25/00832/FUL Smithy Gas Lane Thorney - Change of use, extension and alterations of former blacksmiths to form office and solar panels to roof - this is a positive development as this heritage building is close to collapse. Whilst there are no objections to the change of use and re-development of this property, as it is in a conservation area it is disappointing that the proposed solar panels will be highly visible across the front aspect of the building, particularly as it is single storey.

Speedwatch – checks completed on Station Road – Cllr Mills raised a complaint regarding the speed of the Thorys lorries.

- 1. Warm Welcome continues to meet with good attendance. Cllr Long highlighted the village hall is cold in winter due to clash with 'bread and butter thing' needing open premises doors and suggested changing the day.
- 2. Youth facilities still no volunteers have come forward to support Cllr Mills. Will attend Picnic in the Park. Cllr Allen highlighted the legislation is changing meaning City Council's must provide a senior youth leader although this may well be City based not rural.
