Public discussion -

Stonebridge Cottage- another car hit the chevrons and then down the dyke, which means three cars in three months have had accidents at this spot. The residents would like to see more restrictions on the road, like speed bumps or chicanes as they feared a vehicle will leave the road and crash into their home with fatalities.

City Cllr Allen advised the chevrons were the highways officers' best suggestion. Site meeting will be held this month, which will include highway officers, City Councillors, Parish Councillors and residents. Cllr Allen advised he would take their suggestions to the Highway officers.

Recycling of tractor tyres on Gas Lane- concerns raised by a resident over potential risk to public health. If these are to be removed they must be disposed of by an authorised company. Agenda item next meeting.

A resident spoke to support of upcycling the tyres into planters as at present rather having them burnt and releasing CO2.

Thorney Dyke- Caravan on site. Enforcement advised they are waiting an ecology report. Officers advised no one was living in the caravan. Residents' observations that someone is living in the caravan. Enforcement is not effective in addressing the concerns. The clerk's letters to enforcement have had no response.

Station Road resurfacing- the noise on Station Road is now worse where the join is between the old and new surface. City Cllr Allen to liaise.

- 1. To approve accounts for Payments and Monthly bank reconciliation approved.
- 2. Cemetery. At the last inspection various holes in footpaths were appearing due to subsidence, general wear and tear and animal disturbance. It has not been possible to obtain a quotation for the repairs as they are so diverse. Our contractor has quoted a rate of £25 per hour plus materials on a log and sign rate. It was proposed D Winch, seconded D Halfhide and agreed to proceed with the contractor. Concerns raised about the number of rabbits in the cemetery causing damage. It was agreed to make it an agenda item.
- 3. Agree contribution to music and providers for picnic in park. Cllr Francis left the room. It was proposed M Long, seconded L Moore and agreed to donate £50 to school (who supplied power) and £100 towards incurred expenses for music. Cllr Francis rejoined the meeting.

2829/25-26 Parish Council business

- 1. Picnic in the Park review. To comply with various regulations Thorney Parish Council obtains a PRS licence for the music, a temporary event licence from Peterborough City Council, held a first aid kit, sterile wipes and water at the Thorney Parish Council gazebo, submitted for approval by Peterborough City Council risk assessment for a Thorney Parish Council function and risk assessment for the mobile provider of food and drink. The function was advertised by a leaflet drop to all homes in the village and outlying areas where possible, on social media, on Thorney Parish Council and Peterborough City Council websites. Despite this organisation, youngsters football match conflicted with setup preparations. M Long thanked the Clerk for the work he completed behind the scenes. J Francis suggested creating a smaller area and booking any stalls in advance. The Chair suggested a sub-committee with J Francis and L Moore, with Brian Parker to look at next years event.
- 2. Digital Inclusion Rural Opportunity and funding update
 There will be a rural inclusion hub (that will circulate around Parishes) which will include
 Thorney. Looking to coordinate this with the Warm Welcome.
- 3. Use of glyphosate Glyphosate is the world's most used herbicide and is sprayed regularly to control unwanted vegetation in public spaces, gardens and in agriculture. It's rarely used on its own but is an active ingredient in many herbicides. The use of glyphosate to control unwanted vegetation is highly controversial. There's lots of scientific research and studies to both approve and disapprove its toxicity. European Food Safety Authority (EFSA), stated that glyphosate is 'unlikely to pose a carcinogenic hazard to humans.' However, this is now under review. Some Councillors are of the view that it should not be used on the streets of Thorney by Peterborough City Council to control vegetation. Peterborough City Council point out that it is EU approved and therefore can be used.

It was agreed to write to Aragon to raise our concerns over the application of the weedkiller and ask for an alternative for Thorney streets.
