## 2889/25-26 Parish Council business

1. Parish Council enforcement complaint - our complaint was because of our perceived inaction on the Development of car storage at 4 Acres. This was some months ago and we have now received a response from Peterborough City Council – their reply email is précised below:

“We needed to take advice from the Head of Legal services, in order to determine if your complaint could be accepted from a Parish council. My apologies that there has been a delay whilst this has been confirmed.

They have confirmed that as per the guidance of the Local Government and Social Care Ombudsman -

*“The Local Government Act 1974 (S34(1)) defines the authorities that can be investigated and who is eligible to use the complaints process.*

***Can the Ombudsman look at a complaint from a parish or town council?***

*No. The law does not allow us to accept a complaint made by an “authority constituted for the purposes of the public service”. This includes parish and town councils.*

Therefore, it is our decision that your complaint cannot be accepted as it is from a Parish council”.

It was agreed the Parish Council would support the residents in making individual complaints regarding the issues. The Clerk will circulate the Parish Council’s original letter and to whom they can write.

2. Digital Inclusion - Rural Opportunity and funding – no further update at present.
3. “The Spinney” – The environment officer suggested the following
  - 1/ Bird/bat/ owl boxes (possibly one of each)- these will need pricing and installing by Aragon Services
  - 2/ Bug/hedgehog hotels- these would not be needed as there were areas that has piles of discarded tree trimmings that are ideal bug and hedgehog hotels. Suggested signage at these areas to advise visitors it was a habitat for wildlife

3/ additional sign at entrance to indicate the spinney is a wildlife area, plus three smaller signs highlighting certain areas may contain hedgehogs/ insects/ bugs.

These items have been agreed by Parks Officer, and the Clerk is liaising with him and Aragon services regarding a price.

A pond was suggested, but at the present time the Parish Council will not pursue this option.

Cllr Long received an email regarding the area raising concerns regarding drug tacking and damage to trees.

On the 23<sup>rd</sup> of December the Parish Council met the Wildlife Officer and he advised that he believed the tree damage is historical and not caused by children. We saw no evidence of drug paraphernalia. The Village Warden checks the area twice a week and has found no evidence. Mrs Long will respond to the email.

4. Christmas Hampers – delivered to school for distribution. Thanks to Mrs Long, Mrs Moore and Mrs Halfhide for creating and delivering the hampers.

### **2. Planning Applications and other matters.**

25/01640/CTR For Fell Common Ash tree (T01) at 4 Crown Close Thorney – application states “Removal of one Common Ash tree T01 due the exhibiting low vitality”. Thorney Parish Council cannot agree with the felling of this tree on the basis of the information we have. If the Tree Officer agrees with the application, Thorney Parish Council request a condition that a suitable tree is planted as a replacement

25/01509/FUL Dalmark Grain Knarr Farm Wisbech Road - Part change of use from B8 storage to vehicle repair (Sui Generis). Thorney Parish Council wishes to register a formal objection to planning application **25/01509/FUL** for the part change of use from B8 storage to a vehicle repair operation (Sui Generis) at Dalmark Grain, Knarr Farm, Wisbech Road, Thorney.

While the Parish Council recognises the need for local employment and the reuse of existing buildings, the proposal raises significant concerns—primarily related to **highway safety, traffic impact, and non-compliance with relevant planning policy**. These concerns were detailed in our previous response.
